A. EXCEL VILLAS ABUJA is located Sabon Lugbe West Ext Layout, Abuja Municipal Area, Abuja.
- Q2. WHO ARE THE OWNERS / DEVELOPERS OF EXCEL VILLAS ABUJA?**
A. PWAN ROYALE, a Leading Real Estate Company with offices in Lekki, Lagos State & Abuja.
- Q3. WHAT TYPE OF TITLE DOES EXCEL VILLAS ABUJA HAVE ON THE LAND?**
A. Right of Occupancy.
- Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?**
