**Q1. WHERE IS EXCEL VILLAS OSHOROKO?**

A. EXCEL VILLAS OSHOROKO is an undeveloped parcel of land situated at Oshoroko, in Ibeju Lekki L.G.A, Lagos State

**Q2. WHO ARE THE OWNERS / DEVELOPERS OF EXCEL VILLAS OSHOROKO?**

A. PWAN ROYALE, a Leading Real Estate Company with offices in Lekki, Lagos, Asaba, Delta State & Port Harcourt, Rivers State.

**Q3. WHAT TYPE OF TITLE DOES EXCEL VILLAS OSHOROKO HAVE ON THE LAND?**

A. Certificate of Occupancy ( C of O)

**Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?**

A. The land is free from every known government acquisition or interest and adverse claims.
