**Q1. WHERE IS REJOICE GARDENS IBADAN?**

A. REJOICE GARDENS IBADAN is an undeveloped parcel of land situated at Babatope Obatedo Village, Off Ibadan-Ilorin Expressway Road, Akinyele Area, Ibadan., Ibadan, Oyo State.

**Q2. WHO ARE THE OWNERS/DEVELOPERS OF REJOICE GARDENS IBADAN?**
