Q1. WHERE IS REJOICE VILLAS IKORODU?

A. REJOICE VILLAS IKORODU is located along Ikorodu-Itokin Road, Salabo Village, Isiu Town, Ikorodu Local Government Area, Lagos.

Q2. WHO ARE THE OWNERS / DEVELOPERS OF REJOICE VILLAS IKORODU?

A. PWAN ROYALE, a Leading Real Estate Company with offices in Lekki, Lagos State & Port Harcourt, Rivers State.
