Q1. WHERE IS ROYAL VILLAS UYO?

A. ROYAL VILLAS UYO is an undeveloped parcel of land situated at Afaha Efiat in Etinan Local Government Area, Akwa-Ibom State.

Q2. WHO ARE THE OWNERS / DEVELOPERS OF ROYAL VILLAS UYO?

A. PWAN ROYALE, a Leading Real Estate Company with offices in Uyo, Akwa Ibom State & Lekki, Lagos State.

Q3. WHAT TYPE OF TITLE DOES ROYAL VILLAS UYO HAVE ON THE LAND?

A. Registered Survey & Deed of Assignment

Q4. ARE THERE ANY ENCUMBRANCES ON THE LAND?

A. The land is free from every known government acquisition or interest and adverse claims.

Q5. WHAT IS THE PAYMENT STRUCTURE?

- A. Outright payment of N3, 500, 000 only per plot for 464sqm.
- B. 6 Months payment of N3, 800, 000 only per plot for 464sqm.
