**Q1. WHERE IS ROYALE WATERS?**

A. ROYALE WATERS is an undeveloped parcel of land situated Igbogun Village, Ibeju-Lekki

**Q2. WHO ARE THE OWNERS/DEVELOPERS OF ROYALE WATERS?**

A. PWAN ROYALE, a Leading Real Estate Company with offices in Lekki, Lagos State & Port Harcourt, Rivers State.
