**Q1. WHERE IS SACRED HEART PHASE I?**

A. SACRED HEART PHASE I is an undeveloped parcel of land situated at Umedi/Umuwuagwu Village, Ibusa, Asaba, Delta State

**Q2. WHO ARE THE OWNERS/DEVELOPERS OF SACRED HEART PHASE I?**

**Q3. WHAT TYPE OF TITLE DOES SACRED HEART PHASE I HAVE ON THE LAND?**
